## General Information

The goal of the D.M. Figley Company Construction Industry Award is to encourage more young people to attend college and receive a 2 or 4 year college degree. We hope to help develop future leaders who value the construction industry and who recognize the need to give back to our community.

## The Awards

This year, the D.M. Figley Company is providing a \$500 award to a maximum of 5 worthy students. The scholarship is being awarded for the 2010-2011 school year. Each participant is allowed to receive the award for a maximum of 2 consecutive years.

## Who is Eligible?

Men and Women who are pre-university or pre-college students (age 17-25) at the time of application and demonstrate:

- Evidence of one parent currently working within the construction industry.
- Evidence of dedication to pursuing higher education.
- Evidence of monetary need.
- Evidence of enrollment in an Accredited College or University.

## Application Requirements

- Completion of the official application (may be printed or downloaded from the D.M. Figley Company, Web site, [www.dmfigley.com](http://www.dmfigley.com)) and include:
- Verification of current enrollment by school official
- One confidential recommendation from an adult, not related to the applicant, such as teachers, school officials or community leaders.

*Supporting documentation not requested will not be considered.* All applications and supporting information become the property of D.M. Figley Company. D.M. Figley Company has final authority over any aspect of the Awards.

## Application process

All application materials must be received at D.M. Figley Company, 10 Kelly Court, Menlo Park, CA 94025, by the printed deadline.

D.M. Figley Company will select up to five applications. A D.M. Figley Company Evaluating Committee reviews the applications and selects the five applicants. D.M. Figley Company will not accept any applications from any persons of whom family members currently work for D.M. Figley Company. After approval by the D.M. Figley Company Evaluating Committee, the D.M. Figley Company will provide the awards and certificates to the recipients.
